Appendix 8.4: Parking of Commercial Vehicles

CCR: Number 11, No Commercial Use

No property of the subdivision shall be used for business or commercial purposes. No owner or occupant within the subdivision shall park, or permit to be parked, a commercial vehicle such as log trucks, dump trucks, tractor-trailer rigs, or any other vehicle except for passenger automobiles (including pickups) upon property, including streets, in the subdivision.

No commercial signs shall be erected on the property except real estate sales signs of not more than five (5) square feet advertising property within the subdivision for sale or rent.

CCR: Number 16, Rules and Regulations

The Board from time-to-time may adopt, modify or revoke rules and regulations governing the conduct of persons and the operation and use of the property as it may deem necessary or appropriate in order to ensure the peaceful and orderly use and enjoyment of the property.

Board Approved Parking of a Commercial Vehicle and Vehicle Signage

A non-approved commercial vehicle that is used for business outside the subdivision may be parked in the garage or behind a fence if properly screened. Vehicles that cannot be fully screened must be parked outside the subdivision.

A permit shall be granted to park a branded government emergency response automobile, van or pickup truck if the vehicle is required for 24-hour emergency response.

A permit shall be granted by a Board member to park a commercial vehicle on a property for a specified period of time while work is being performed in subdivision.

Signs on approved commercial vehicles parked within the subdivision are limited to not more than three signs on any vehicle. No one sign can exceed five square feet or 720 square inches.

Acceptable via Permit



A branded government emergency response automobile, van or pickup truck with signage that exceed limits will be granted a permit for outdoor parking if the vehicle is required for 24-hour emergency response.
